In such cases, we may only disclose Personal Information to the extent of such purposes provided in 1(2).

(2) Disclosure to other third parties

We may disclose Personal Information to certain trusted third party service providers, including both domestic and overseas, where necessary to carry out our business operations.

Unless legally required, we will not disclose Personal Information for purposes not provided in 1(2) without informing you and taking any necessary steps in advance as required under applicable law. Regardless of the purpose, we will not sell or rent Personal Information to a third party without your express consent.

8. MANAGEMENT AND SAFEGUARDING OF PERSONAL INFORMATION

We will make its best efforts to manage and safeguard the Personal Information so as not to divulge it to any third party for any usage or purpose other than those provided in 1(2).
